

# Endowment Example

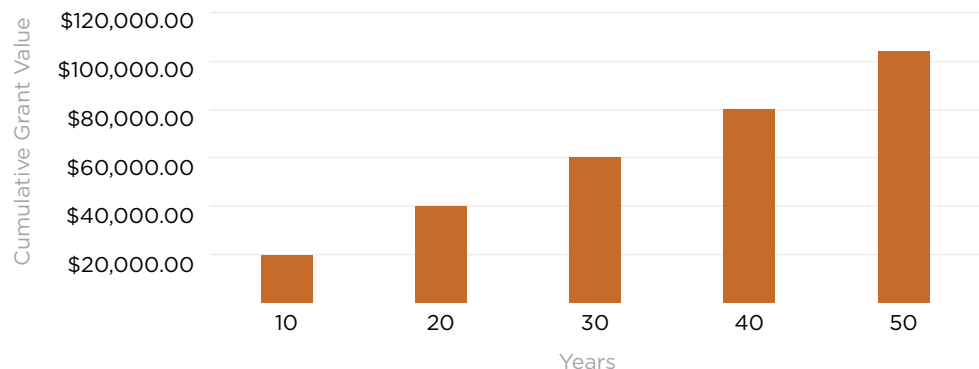
